- (1) With reference to his reply to question 2335 on 9 November 2020 regarding farm attacks in Gauteng during the period 1 June to 31 September, in which certain farm murders were not listed (details furnished), for each of these cases, why was each of the specified murders not listed;
- (2) whether an investigation into each of the murders is underway; if not, why not; if so, on what date is the investigation expected to be completed;
- (3) whether any arrests have been made; if not, what is the position in this regard; if so, what is the status of criminal prosecution against the perpetrator(s)?

ii	Farmer was shot and killed on 30 June 2020 in Cullinan (Dewagendrift) CAS 1/7/2020.	Cullinan CAS 01/07/2020	The case was identified in the response to question 2335. The victim was a farm worker.


